# Hennepin County One-Day DWI Program

## Program Overview

The Hennepin County One-Day DWI Program was created to provide a timely and consistent response to prevent repeat offenses for the 3000-4000 first-time offenders sentenced annually for a DWI in Hennepin County.

The One-Day program combines aspects of alcohol education, cognitive therapy, self-assessment, and a victim impact panel.



## Program Rules

Breaks will be given for lunch and dinner (meals and refrigeration will not be provided).

Smoking is not permitted.

No one may attend under the influence of alcohol/drugs. Participants may be asked to submit to a breathalyzer at the door.

Anyone terminated from the program for any reason, including being under the influence of alcohol/drugs, will need to reschedule and pay a rescheduling fee.

## Program Information

- ◆ Designed for first time DWI clients with a BAC (Blood Alcohol Level) of .19 or less.
- ◆ Program must be completed within 90 days of sentencing.
- ◆ Program runs every Saturday from 7:30 a.m. to 6:30 p.m.
- ◆ Program is offered in four convenient metro locations.
- ◆ **Full payment must be received two weeks prior to scheduled attendance.**

## Cost

The cost of the One-Day Program is \$275 (\$200 for public defender clients). **This fee can not be waived by the court.** Program fee must be paid in full by check or money order two weeks prior to class attendance.

- ◆ Mail check or money order to **301 4<sup>th</sup> Ave S, Ste. 680, Minneapolis, MN 55415** Payable to **"Hennepin County One-Day DWI Program"**-include your case number.
- ◆ You may also pay in person at the probation office located by the court where you were sentenced.

## Program Registration

- ◆ Clients who have not pre-registered or whose payment has not been received will not be allowed entrance to the program.

## Restitution

Clients involved in an accident may also have to pay restitution. The court will decide this on a case by case basis.

## Sentence to Service (STS) (612) 596-9220

Some clients may be referred to STS in addition to the One-Day program. Clients must call 612-596-9220 to schedule STS.
