Interlock Requirements for All Participants:

1. Must be 18+.
2. Must have device installed in all vehicles driver intends to use for program.
3. Must provide proof of insurance coverage in driver's name for at least one year for all vehicles used in program.
4. May only use vehicles w/ interlock device installed.
5. May use company-owned vehicle w/out interlock device during normal course of work if employer provides written consent.
